- 2. Data entry: ISBN /ISSN, price, main entries, title, subtitle, author responsibility, edition, imprint (place, publishers, years) physical description (pages, dimensional sizes, a companion materials etc.) series, general note, bibliography and index notes, added entries and sub self-self numbers (location). Data base standard as a library of congress.
- **3. MARC 21**: Leaders, fixed field, indicators, tags, related code, country code, language code, institution name, biblio, source information code.
